**CONSENT SCHEDULING ORDER**

The Court denied Plaintiffs' motion for a preliminary injunction and ordered the parties to submit a consent scheduling order, if possible, regarding the "timetable for conducting discovery and briefing the remaining issues."

Order at 29 (Aug. 4, 2015), ECF No. 25. The parties have agreed to the following proposal.

The parties request that the Court stay this case pending the Securities and Exchange Commission's resolution of Plaintiffs' pending appeal of the initial decision issued by the administrative law judge. A stay will protect the parties' and the Court's time and resources by eliminating potentially unnecessary litigation. The parties will inform the Court of a decision by the Commission on

plaintiffs' appeal within seven days of its issuance and, if appropriate, propose a schedule for further proceedings in this case.
